

NAAGA – Henry O. Flipper Chapter, El Paso, Texas Membership Information and Consent Form



- 1. You must be a paid active member of the National African-American Gun Association (NAAGA), in good standings, and also show proof, via Membership ID #. NAAGA membership dues are paid yearly. Chapter dues are paid monthly. You understand that the local Chapter membership is voluntary and NAAGA membership is required.
- 2. All levels of skill-sets are welcome from beginners to seasoned shooters. Safety, training and proper information is our top priority. You must be willing and able to work with guns. You understand that dealing with or learning how to operate firearms involves both classroom style learning and hands-on learning.
- 3. You must agree to abide by and obey any instructions the Gun Club outlines when participating in any inperson field events. All attendees of field events have free-will and agree to hold the NAAGA and the Henry O. Flipper Gun Club and any affiliates harmless and <u>NOT LIABLE</u> for any unlawful actions, accidents, unforeseeable occurrences, personal, health, or natural emergencies, etc. and understand there is an inherent risk when using any firearms in a public setting. This document serves as a <u>General Liability Waiver</u> and additional waivers may be used for field events.
- 4. You must be 21 years or older to be a member of the Henry O. Flipper Gun Club. You must be able to possess a firearm according to all Federal laws and Texas State laws. Some basic State and Federal Laws that prevent a person from possessing a firearm include but not limited to: A felon, domestic violence, mental illness, and Non-Citizens. Record expunction must be validated and approved by the Club President before being admitted as a member.
- 5. Membership in the Henry O. Flipper Gun Club can be revoked at any time for violating membership rules and criteria. Also, if the Gun Club leadership all unanimously agree that a person is not a "good fit" for any reason. If your membership is revoked, no membership dues/donations will not be reimbursed.
- 6. The Club encourages you to be active. Once dues are paid, no refunds will be given, your membership will be active regardless of your participation level within the Club.
- 7. Married, each sign applications/consent forms and pay Club dues as a separately.
- 8. All members must be treated with dignity, respect, and courtesy without slander.
- 9. No member, except the Club President, is allowed to speak with any form of media about the Club. Anyone designated must have permission from the Club President.
- 10. Any person who holds a Leadership role agrees to perform their duties in a professional manner and to the best of their abilities.
- 11. **New Rules** and **Criteria** can be modified at any time but only if all of the members holding a leadership role agree to the change(s). Once agreed, a new Rule or Criteria can be added, removed, or modified from that point forward.
- 12. **All New Members** must sign and date this membership information and consent form which signifies that you have read the terms and conditions of membership.
- 13. **Media Agreement** I hereby and irrevocably consent to the use, publication, distribution, broadcasting, reproduction, live-streaming, editing, recording, posting, copyrighting, licensing, digitization, and/or rerelease of the released Media.
- 14. You can withdraw your membership at any time with a written letter or email addressed to the Club President and Secretary affirming this.
- 15. This Consent Form is only required to be signed the first year of membership; however, the rules and criteria apply in perpetuity, as long as you are a member. If inactive for over a year, an updated consent form may be required.
